

JAGUAR TURN-IN CHECKLIST

01 PREPARE TO RETURN YOUR JAGUAR

60 DAYS BEFORE YOU TURN IN YOUR VEHICLE

- Schedule a pre-inspection¹ online at AutoVINLive.com using your VIN and account number or contact us to make the appointment.
- Review the online condition report about 24 hours after the pre-inspection.
- Contact your Jaguar retailer to make repairs.
- If you make repairs to reduce your end-of-term liability², let us know by sending a message at chase.com.

14 DAYS BEFORE YOU TURN IN YOUR VEHICLE

- Cancel any automatic recurring payments after your last payment has cleared.
- Schedule an appointment to return your vehicle to your Jaguar retailer.
- Contact your local Department of Motor Vehicles to see if there are specific turn-in requirements for your area.

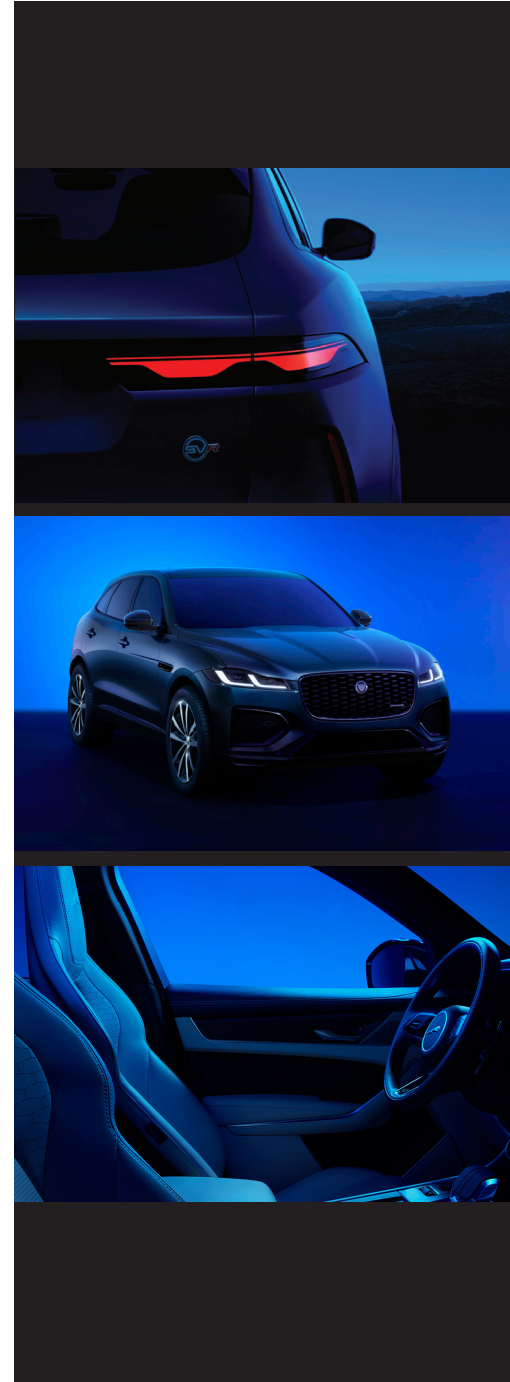
02 RETURN YOUR JAGUAR

- Remove all personal items from the vehicle.
- Clear personal information from the technology in the vehicle.
- Return all original items, including keys, manuals and cargo covers. Complete, sign and date an odometer statement and return it to us.

03 COMPLETE YOUR JAGUAR RETURN

- Complete the Digital Lease Turn-in form or contact us within 1 business day of your vehicle turn-in to ensure we have accurate information for calculating your lease-end bill.
- Pay your lease-end bill. If there are any charges, you can expect to receive your bill within 30-60 days after returning the vehicle. In cases of early vehicle return or when the vehicle is undergoing the sales process, bills may arrive 90-120 days later.

The holder's inspection after the termination of the lease shall be conclusive unless the NH/WI lessee obtains a counter-inspection.

If so, please carefully review the benefits and exclusions of any optional products you purchased. Contact your retailer to complete any repairs prior to turn-in.
